The discussion effectively outlines the properties of the identified compounds; however, it would be strengthened by establishing a more direct connection between these properties and the therapeutic potential of <i>Corchorus olitorius</i> . | The discussion as submitted contained the therapeutic potential (antioxidant, anti-inflammatory, cytotoxic) of identified chemicals in Corchorus olitorius. However, very few were omitted and have been included now. |
